Lifeline Ambulance Service CEO Jim Jones Whistleblower Against DOJ, Treasury, IRS, HHS, Biden, Obama, and Pelosi regarding 2008 Election Fraud involving Medicare Trust Funds

Jones first reported his findings to House Oversight members in 2015, who encouraged him to dig deeper. In 2016, he submitted another briefing report, and in August 2018, he filed a tort claim against HHS for \$140 million in damages incurred by him and Lifeline due to the 2008 election interference by Democrats in charge of Congress.

In 2008, the election was between Obama and McCain/Palin. Jones claims that the Medicare trust fund stopped paying most of its 1.2 million Medicare providers in May 2008 without notice. He believes this was an attack on democracy, as over 52% of the providers, primarily small business owners and free enterprise conservative believers, were eliminated. His tort claim serves as a whistleblower complaint that triggered alarm within HHS and Washington, D.C., leading the DOJ to pursue fictitious tax claims against him, which arose from the non-payment ruse.

They stopped at nothing to discredit him, even while he was still investigating them throughout and after his November 2023 tax trial in Roanoke, VA. The U.S. government refused to produce documents until the day of the trial, threatened witnesses, and withheld documents that could exonerate him, while agents had lied during the process. The 2008 Democratic leadership, led by Speaker Pelosi in the House and Ted Kennedy in the Senate, with Joe Biden, controlled the Medicare trust funds. They orchestrated the Treasury Secretary to halt cash flow to the 1.2 million providers in late May 2008, aiming to suppress the private sector against Obamacare.

By 2009, over 52% of these providers were eliminated, according to CMS data. CMS informed providers that they had to re-enroll, a process that took a year or longer. Jones argues this was

criminal, claiming that the cabal extorted providers to support Obamacare in 2009. He alleges that they threatened to cut 20% of reimbursement if not \$200 billions of Medicare trust funds were used to finance the 2008 election for Obama and Biden. Providers like Lifeline were never paid.

Jones became aware that red states were targeted by 2015 and pieced together the rest of the information during COVID-19. He reported these findings multiple times during the pandemic and became labeled as Public Enemy Number One while stranded outside the U.S. Jones returned in October 2021 with his official report, only to be arrested in Fort Lauderdale on a series of fictitious tax charges for crimes the government created after confirming his data.

Furthermore, he submitted his whistleblower complaint to the House Oversight Committee up to his November 2023 tax trial. Throughout the trial and after, he continued to investigate the matter. In December 2023, he submitted his final whistleblower complaint.
